<u>Consultation Meeting Notice</u>: Department of Homeland Security Draft Environmental Justice Strategic Plan

Dear Tribal Leader:

The Department of Homeland Security (DHS) Office of the Chief Readiness Support Officer and Office for Civil Rights and Civil Liberties are committed to conducting deliberative tribal consultation regarding Department programs, actions, and activities that may impact Tribal Nations in accordance with Executive Order 13175, *Consultation and Coordination with Indian Tribal Governments*, and President Biden's "Memorandum on Tribal Consultation and Strengthening Nation-to-Nation Relationships".

Consistent with these commitments, DHS invites you to consult on the draft DHS Environmental Justice Strategy. Two virtual Tribal consultations will be held in July. The purpose of this government-to-government consultation is to gather Tribal Nations' feedback prior to finalizing the Environmental Justice Strategic Plan.

Published on April 21, 2023, <u>Executive Order 14096</u>, <u>Revitalizing Our Nation's Commitment to</u> <u>Environmental Justice for All</u>, defines environmental justice, or EJ, as the just treatment and meaningful involvement of all people, regardless of income, race, color, national origin, Tribal affiliation, or disability, in agency decision-making and other federal activities that affect human health and the environment so that people:

- 1. are fully protected from disproportionate and adverse human health and environmental effects (including risks) and hazards, including those related to climate change, the cumulative impacts of environmental and other burdens, and the legacy of racism or other structural or systemic barriers; and
- 2. have equitable access to a healthy, sustainable, and resilient environment in which to live, play, work, learn, grow, worship, and engage in cultural and subsistence practices.

The Executive Order calls on federal agencies to develop or revise their EJ Strategic Plans. Since December 2023, DHS has issued a Request for Information in the Federal Register; held three national, virtual listening sessions, with one focused on the perspective of Tribal and indigenous peoples; and presented at two national conferences to solicit feedback on the current Departmental EJ Strategy and discuss new goals and input for its revision.

The Department's commitment to advancing environmental justice and meaningful engagement includes ensuring that under resourced and overburdened communities' voices, perspectives, and lived experiences are heard and reflected in the Department's decision making with respect to its programs and activities that impact human health and the environment. DHS will be holding two

- 2. Are there any key elements or strategies missing from the attached draft Plan that should be included to better support environmental justice initiatives with Tribal Nations?
- 3. What steps can we take to enhance the tribal consultation process with Tribal Nations to continue to garner input on the DHS EJ Program and address Tribal environmental justice concerns?
