#### Dear Tribal Leader:

In November 2023, the Not Invisible Act Commission -- a cross-jurisdictional Federal advisory committee composed of law enforcement, Tribal leaders, Federal partners, service providers, family members of missing and murdered individuals, and survivors -- transmitted its congressionally mandated recommendations to the Department of the Interior, Department of Justice and U.S. Congress on how the U.S. can best resolve the crises of missing and murdered Indigenous peoples (MMIP) and human trafficking (HT). The Commission heard testimony from individuals affected by the MMIP and HT crises in hearings held across the country, including seven states in areas most impacted by the crises and a two-day virtual hearing. During the hearings, several witnesses expressed frustration about the lack of national/local media coverage of MMIP cases.

As part of the Federal response to the Commission's recommendations on how to combat the MMIP and HT crises, the Department of the Interior and the Department of Justice committed to holding a roundtable to discuss best practices regarding the issue of fair and equitable media coverages of these issues, which have been underfunded and underreported for decades.

This roundtable will provide a venue for dialogue between Tribal leaders, advocates, journalists, and Federal agencies to discuss this issue. The conversation will inform the development of a set of guidelines and best practices called for in Chapter 1, recommendation E1, of the Commission's report.
